USAGE AND DOSAGE

Rub in

Before working, rub approx. 1 ml pr 88 liquid onto your hands – especially to the fingernails and cuticles – and leave to dry.

Wash off

After you have finished working wash your hands gradually adding water, rinse off thoroughly and dry. The dirt will be removed together with pr 88.
